

Post-Graduation

- Available for F-1 international students after each degree level
- 12 months of full-time work authorization
- Applies to all majors
- No Sponsorship Required!



STEM OPT Extension

- Additional 24 months for degrees in Science, Technology, Engineering, or Math
- Lifetime limit of 2 periods of STEM OPT.
- Total of 3 years of U.S. work authorization
- Enables long-term project planning and workforce stability




Health care tech, engineering, logistics, data analytics, financial modeling.

Hiring International Students – What is CPT?

Curricular Practical Training (CPT): Work Authorization for F-1 Students Before Graduation

What Employers Should Know: NO SPONSORSHIP REQUIRED!

- CPT allows international students to work while still enrolled in school.
- Must be integral to the student's degree program.
- Can be part-time or full-time. Full-time CPT for 12 months will exhaust OPT.

How Employers Benefit:

- No government filing or cost student handles approval with their university
- Access to talent early in the academic pipeline
- Great option for internships, externships, project-based roles

Industries that actively use CPT

- Health care (e.g., clinical rotations, health tech internships)
- Aerospace & engineering (e.g., summer design internships)
- Industrial supply (e.g., operations and logistics co-ops)
- Financial consulting (e.g., analytics and accounting internships)

Quick Tip:

Ask candidates if they're eligible for CPT when discussing internships!

*Requires school approval and must be related to the student's field of study.

H-1Bs

- Specialty Occupations (that require at least a bachelor's degree).
- Degree MUST be related to the job offered.
- Very popular for STEM fields.
- LOTTERY!
 - o 85,000 spots.
- Preference for U.S. Master's Students.
- Lottery registration takes place in March for the upcoming "fiscal year" beginning October 1st.
- Up to 3 year validity.

Employer Tip:

Hiring on OPT/STEM OPT allows multiple attempts (up to 4) at the H-1B lottery!





TN Visas

- Available to Canadian and Mexican Nationals.
- Valid for 3 years at a time and can be extended indefinitely.
- List of qualifying occupations (and qualifying degrees and licenses for those occupations)
- Quick processing often issued at the border
- Common for roles in finance, healthcare, engineering, R&D, supply chain, right





IMMIGRANT VISAS (green cards)

There are 2 Main Types:

Employment-Based (Today's Subject!)

And

Family-Based (Marriage, Child, Parent, Sibling)

Most Common Types of Employment-Based Immigrant Visas:

EB-2: Advanced Degree & Exceptional Ability (Labor certification required)

- **EB-2 (Advanced Degree):** Master's degree (or bachelor's + 5 years of experience).
- EB-2 (Exceptional Ability): Significant expertise in sciences, arts, or business.

EB-3: Skilled Workers & Professionals (Labor certification required)

- **Professionals:** Jobs requiring a **bachelor's degree**.
- Skilled Workers: Jobs requiring 2+ years of experience.
- Other Workers: Jobs requiring less than 2 years of training

Visa Bulletin & Wait Times

Depends on:

- Country of birth,
- EB category (level of education required by the job and possessed by the applicant)
- Priority date (filing order).

Current Trends:

EB-2 & EB-3 wait times longer for some countries (India, China)

Early planning = less disruption

OPT/STEM OPT can be used to bridge green card timeline, while simultaneously applying for the H-1B lottery every year to minimize risk.
