- Baseline is meant to enhance offerings and potential of organizations
- Sets a minimum level of expectations by which Student Organizations should meet to remain active and funded
- Opportunity for Magis in action

PARTICIPATING ORGANIZATIONS

Clubs.

- Baseline does not apply to:
 - Subordinate Bodies
 - Sororities/Fraternities
 - Student Departments
 - Honorary Societies
 - Department-Sponsored Organizations
 - Limited Affiliation Groups
 - Club Sports
 - Conditional Status Groups





- Increase number of times a Club meets each semester
- Increase number of advisor meetings
- Increase amount of programming and events targeting university community
- Increase service engagement with larger community
- Increase usage of the Student Activity Fee, SORF, and fundraising efforts
- Increase learning and leadership development opportunities



BASELINE TIERS 2025-2026

- Tiers have been determined to more equitably monitor groups
- Tiers are based on the average of your funding from the most recent 3 allocation cycles
- Tier I average \$11,000+
- Tier 2 average between \$2,500 and \$11,000
- Tier 3 average between \$300 and \$2,500
- Tier 4 average less than \$300



BASELINE

STANDARDS: MEETING REQUIREMENTS

- Hold a set number of meetings per semester, based on Tier designation
- Promoted/advertised to entire Club roster
- General membership meeting
- Agenda should be sent to members in advance
- Focused on Club business (ex. upcoming events, officer elections, opportunities to collaborate with other groups, etc.)
- Create as an event at least two weeks in advance and log attendance. No need to submit monthly meeting minutes/agenda for verification via EngageXU



BASELINE GENERAL MEETING REQUIREMENT

- Tier I 5 general body meetings per semester
- Tier 2 4 general body meetings per semester
- Tier 3 3 general body meetings per semester
- Tier 4 3 general body meetings per semester

BASELINE ::::STANDARDS: FACULTY/STAFF ENGAGEMENT

- Meet with faculty/staff advisors regularly, based on tier designation
- Scheduled in advance
- Officers meeting with advisor OR advisor attending general membership meeting can count
- No need to register as a separate event via EngageXU two weeks ahead
- Submit Monthly Agenda/Minutes for Advisor Meetings via EngageXU form to Student Involvement



BASELINE

ADVISOR MEETING REQUIREMENT

- Tier I 5 advisor meetings per semester
- Tier 2 4 advisor meetings per semester
- Tier 3 3 advisor meetings per semester
- Tier 4 2 advisor meetings per semester



- Hold events every semester outside of regular Club meeting
- Can include:
 - Week of Welcome program
 - Approved fundraiser/trip
 - On or off campus events exclusively for group members (beyond general meeting content)
 - On-campus events for campus community
 - Service project
- Submit as events in EngageXU at least two weeks in advance (three weeks for travel)



BASELINE STANDARDS: PROGRAMS/EVENTS

- Tier I 6 programs/events per semester
- Tier 2 4 programs/events per semester
- Tier 3 3 programs/events per semester
- Tier 4 2 programs/events per semester

BASELINE :::: STANDARDS: SERVICE ENGAGEMENT

- Participate in at least one service opportunity per year
- Can be independent group activity or already existing service opportunity (ex. Community Action Day)
- Goal of 80% of membership
- Can count as a program/event (if active by design)
- Report in Service Verification Form to Student Involvement via EngageXU
 - Additional documentation or evidence from service site/organizer is needed



BASELINE STANDARDS: STUDENT ACTIVITY FEE USAGE

- Must spend all funding allocated from SGA
- Encouraged to use SORF and fundraising for additional funding
- Funding does not carry over from year to year, unless fundraised
- Tier I and Tier 2 Clubs are required to conduct at least one fundraiser per year (dues collection and SORF proposals do not count)





- Tiers 1-4: 2 officers should attend the annual Student Organization Workshops held during the fall
- Tiers 1-4: President and Treasurer should attend the annual Student Organization Academy
- Tiers 1-3: Treasurer should attend Club Budget Workshops
- Tiers 1-2: Outgoing and incoming Presidents are required to participate in Student Organization Officer Transition Workshops (Tier 3 is strongly encouraged)
- Tiers 1: Organization is expected to invest in leadership education for younger members by sending at least two first-year or sophomore students to the Emerging Leaders Retreat



 Tiers 1-4: Presidents and select officers must submit the Mid-Year report by the specified deadline in December, via EngageXU, along with the accompanying survey

• Tiers 1-4: Outgoing or continuing Presidents are required to submit a Year End

report by the specified deadline in April via EngageXU



BASELINE BUDGET PROPOSALS

- Revamped for more transparent, equity-focused allocations
- Tiers 1-3: Clubs will be required to submit a detailed Student Club Budget
 Allocation Request annually and will meet with the SGA Student Organizations
 Committee (SOC) to pitch their request and answer related questions. Clubs will
 be scored against a rubric to determine their allocation for the upcoming year. SOC
 will consult with both SGA Executives and SGA Advisors to determine and finalize
 proposed club allocations. Final proposed allocations are presented to the Student
 Senate for discussion and vote.
- Tier 4: Clubs that are up-to-date on Baseline reporting are eligible to request up to \$300 without submitting a detailed request. Eligible Clubs in this tier requesting up to \$300 will be awarded their allocation **automatically** for the following year.



- Clubs will be evaluated at the end of each semester according to the Baseline Standards
- Clubs not meeting standards will be notified and placed on probation
 - Clubs have until the end of the following semester to meet all requirements to return to a normal, active status
 - Clubs not meeting requirements after two consecutive semesters will lose Club status and EngageXU page
- During probation, the Club may be asked to meeting with OSI staff members to discuss their progress and work toward meeting the requirements



- Clubs can soon track Baseline progress through the Baseline tracker
- This will allows you to stay up-to-date with all requirements
