

BRAVE Peer Educators

Position Description: Under the supervision of the Director of Student Wellbeing Services, the BRAVE Peer Educators will be responsible for facilitating power and gender-based violence prevention workshops, supporting violence prevention awareness efforts, and promoting support services throughout the 2024-2025 academic year.

Responsibilities and Expectations:

- Attend mandatory 14 hours of on-boarding training. Students who apply must be available on the following dates/times for training:
 - Saturday, September 7, 2024 from 9am-4pm
 - Sunday, September 8, 2024 from 9am-4pm
- Attend mandatory in-services training on the first Saturday of the month from 9am-12pm.
 - October 5, 2024
 - November 2, 2024
 - February 1, 2025
 - March 1, 2025
 - April 5, 2025
- Attend 1-hour bi-weekly team meetings. Dates and times to be determined.
- Co-facilitate power and gender-based violence prevention workshops to classes, athletic teams, student organizations, resident advisors, etc. per request.
- Submit required paperwork after workshops and maintain records.
- Participate in BRAVE leadership development activities, community building efforts, and continuing education opportunities.
- Respect the privacy of all individuals involved in power and gender-based violence matters and maintain confidentiality in interactions within the community as appropriate.

Additional job responsibilities include: Active participation in individual check-ins and supervision as needed; developing and implementing outreach efforts to engage marginalized and/or vulnerable populations; developing and maintaining effective, professional, and collaborative relationships with others in the community; performing other duties as needed.

Required Qualifications:

- Students are required to be in good standing. For BRAVE Peer Educators, this means:
 - Maintaining a cumulative GPA of 3.0
 - Not on University or Residence Life Probation
 - No past due conduct sanctions
- Ability to carry out tasks in an independent manner and work in small groups.
- Availability to work approximately 3-5 hours per week during 2024-2025 academic year.
- Demonstrate an awareness of the sensitive nature of the position and importance of confidentiality.
- Intermediate awareness of and interest in issues of power and gender-based violence.
- Experience or interest in working with diverse populations.
